1. REGISTRATION OF TONGAN BIRTHS OCCURRING BOARD

Nationality Act, section 7 of the Registrar General's Births and Deaths Regulations

FEE: \$16

Decision maker: Sub-registrar

- Letter of application by either parent in legitimate cases or mother in illegitimate cases (where these people are not in Tonga they may authorize someone in writing in Tonga to act on their behalf)
- Affidavit of applicant
Must include the following:
 - Marital status of mother at time of birth
 - Nationality of mother/father at time of birth
 - Relationship to or connection with the person the subject of the registration
 - Believes that the certificate produced to be genuine and its contents true
- Original Tongan passport of mother or father
- Original Foreign birth certificate of subject child
- Original Marriage certificate of parents where child was born legitimate
- Original Certificate of Naturalization where applicable
- Written consent of child (over 16 age)
- Photocopy of foreign passport bio-data - child (over 18 age)
- Letter of authorization where applicable (MUST BE NOTARIZED OR WITNESSED BY JP)

1. LESISITA 'O E FA'ELE MULI

TOTONGI: \$16

Faitu'utu'uni: Tokoni Faileisisita

- Tohi kole mei ha taha 'o e ongo matu'a 'okapau ko e leka mali pe ko e fa'e kapau ko e tokotaha ta'e mali ke lesisita (Kapau 'oku 'i muli 'a e ongomatu'a pe fa'e, 'e lava pe ke fakamafai'i mai ha taha 'i Tonga ni ke ne fakahu e tohi kole)
- Fuakava poupu 'a e tokotaha kole
Kuo pau ke fakaha ai eni:
 - Na'e mali pe te'eki ai mali 'a e fa'e he taimi 'o hono fa'ele'i 'a e tokotaha ke lesisita
 - Tangata'i fonua 'o e tamai/fa'e he taimi 'o e fanau'i 'o e tokotaha ke lesisita
 - Tu'unga 'oku ne pehe ai ko e Tangata'i fonua Tonga 'a e tokotaha ke lesista
 - Fekau'aki pe kainga mo e tokotaha ke lesisita

- Tatau mo'oni (original) 'o e tohi liliu kakai (naturalization)
- Tohi 'o e leka 'oku loto ke lesisita ia 'i Tonga ni (kapau ku 'ova hono ta'u motu'a he 16)
- Tatau (copy) 'o e paasipooti muli 'o e leka (bio-data)
- Tohi fakamafai (KUOPAU KE FAKAMO'ONI 'IMU'A 'I HA LOEA, JP PE NOTARY PUBLIC)

2. MARRIED WOMAN REGISTERING AN ILLEGITIMATE CHILD BORN ABROAD

Nationality Act, Legitimacy Act, Sections 6 and 7 of the Registrar General's Births and Deaths Regulations

FEE: \$32

Decision maker: Registrar General

- Letter of application by mother or father if name inserted on foreign birth certificate or authorized party (authorization must be WITNESSED by JP or Notary Public)
- Affidavit of applicant
 - Must include the following:***
 - Nationality of mother/ biological father at time of birth (if name of father appears in subject child's foreign birth certificate)
 - Relationship to or connection with the person the subject of the registration
 - Believes that the certificate produced to be genuine and its contents true
 - When mother was married
 - When mother separated from husband or if separation was temporary, specific period in question
 - When co-habitation with biological father occur and where
 - Who was aware of relationship (independent witness) and how
 - Full name of child, date of birth, place of birth, gender
 - Declare that the sexual relations with bio-father was exclusive and husband did not have access
- Affidavit of Independent witness to the co-habitation (proving that parties had no access to each other when child could have been conceived as required by Practice Direction 3/ 2007) (where applicable)
- Original Tongan passport of mother or natural father (father's passport may be accepted where name of father appears in subject child's foreign birth certificate)
- Original Foreign birth certificate of subject child
- Original Marriage certificate of mother or Decree Absolute if divorced
- Written consent of child (over 16 age)
- Photocopy of foreign passport bio-data - child (over 18 age)

2. FEFINE MALI KE LESISITA TOMUI HA 'ANE LEKA TA'EMALI NA'E FA'ELE'I 'I MULI

TOTONGI: \$16

Faitu'utu'uni: Failesisita Seniale

Lao ki he Kakai 'o Tonga, kupu 6 mo e 7 'o e Ngaahi Tu'utu'uni 'ae Failesisita Seniale ki he Fa'ele mo e Pekia

- Tohi kole mei he fa'e pe ko e tamai kapau ku ha hono hingoa he tohita'u muli 'ae tokotaha ke lesisita, pe ko ha no fakamafai'i 'o ha taha ke ne fakahu 'a e tohi kole
- Fuakava 'o e tokotaha kole
Kuo pau ke fakaha ai eni:
 - Tangata'i fonua pe 'o e fa'e/tamai he taimi ne fa'ele'i ai e tokotaha ke lesisita ('e lava pe 'a e tamai kapau 'oku ha hono hingoa he tohita'u muli)
 - Fekau'aki pe kainga mo e tokotaha ko ia 'oku 'ai ke lesisita
 - Tui 'oku totonu mo mo'oni 'a e ngaahi tohi fakamo'oni na'e 'omai
 - Na'e mali e fa'e 'anefe
 - Na'e mavae fakaku mo hono mali pea kapau na'e mavae taimi nounou pe, ko fe 'a e vaha'a taimi koia
 - Na'e kamata fakaku 'a e nonofo fakamali mo e tamai fakanatula 'o e tokotaha ke lesisita
 - Ko hai 'a e fakamo'oni tau'ataina na'e 'ilo ki he nonofo fakamali moe tamai fakanatulua pea na'e anga fefe
 - Hingoa kakato 'o e tokotaha ke lesisita, 'aho fa'ele'i, feitu'u fa'ele'i, tangata pe fefine
 - Fakapapau na'e 'ikai ke toe nonofo fakamali 'a e fa'e mo hono husepaniti 'i he vaha'a taimi ko ia na'e fanau'i ai 'a e tokotaha ke lesisita
- Fuakava pou pou 'o e fakamo'oni tau'ataina ki he nonofo fakamali (fakaha mahino ai na'e 'ikai toe nonofo fakamali 'a e fa'e pea mo e husepaniti 'i he vah'a taimi ko eni na'e fanau'i ai e tokotaha ke lesisita 'o hange koia 'oku fiema'u 'ehe Practice Direction 3/2007) ('oka fiema'u)
- Tatau mo'oni 'o e Paasipooti Tonga 'o e fa'e pe tamai fakanatula kapau 'oku ha e hingoa 'o e tamai 'i he tohita'u muli) (original)
- Tatau mo'oni (original) 'o e tohita'u muli 'o e lesisita
- Tatau mo'oni (original) 'o e tohi mali 'o e fa'e pe tohi vete kapau kuo vete
- Tohi 'a e tokotaha ke lesisita kapau kuo 'ova he ta'u 16 'oku loto ke lesisita ia 'i Tonga ni
